	21. On 07/24/2026 at around 2317 hours, I, Officer Runyon with the Orange City Police Department, was													
	22. dispatched to a disturbance that had escalated into a shooting with injuries at 2500 Junior St., Orange													
	23. City, Florida, 32763.

26. Upon arriving at the Reserve at Orange City Apartments, I parked on the east side of the complex														

27. in front of the Dollar General and exited my vehicle. I observed a man lying on the ground bleeding,
28. with a female in blue scrubs standing over him. Officer Hoffman, who was already on the scene, indicated
29. the location of the shooter, and Officer Agosto and I proceeded towards the individual.

32. The person who discharged the firearm was parked in a parking space at the back on the east side
33. of the building, relatively close to where the injured man was lying. The shooter was standing in front
34. of his Black 2023 Honda Accord bearing Florida license plate SGH07.

37. Officer Agosto and I placed the individual in handcuffs, and he was identified by his Florida driver's
38. license as Malik Isaac Brown, DOB: 07/21/1999. Malik [REDACTED] LEO_ACTIVE_INVESTIGATION

40. of Malik's car were his two daughters, identified as [REDACTED] JUVENILE_CONFIDENTIAL

44. I remained with Malik while speaking to his parents regarding the children, specifically Krista
45. Isaac, DOB: 05/16/1980, who was approximately 20 minutes away and would take custody of the two children.
46. I then walked to my patrol car, placed Malik in the rear, and returned to talk with the two children.
47. During this time Volusia County Sheriffs Office began assisting by putting up crime scene tape and
48. creating a perimeter around the East side of the parking lot.

51. I first spoke with [REDACTED] JUVENILE and asked her what had happened. She explained that her father, Malik,
52. was driving his ex-girlfriend and the mother of the children, identified as Nicole Pena, DOB: 05/27/1999,
53. to her apartment. Upon their arrival, [REDACTED] JUVENILE stated that Nicole's current boyfriend, identified as
54. Raekwon Angel Gonzalez, DOB: 01/24/1999, came outside and began yelling and cursing at Malik and then
55. began approaching their vehicle in an aggressive manner. [REDACTED] JUVENILE reported that her father began firing
56. his gun towards Raekwon.

59. I then spoke with [REDACTED] JUVENILE and inquired about the incident. Due to the language barrier stemming from
60. her young age, she said something quite similar to what [REDACTED] JUVENILE mentioned. [REDACTED] JUVENILE stated that she heard
61. someone shouting at her dad followed by gunfire. Both daughters appeared nervous and frightened, visibly
62. shaking from having witnessed the event.
63. Shortly thereafter, the grandparents arrived, and the two children left with them since their mother,
64. Pena, was unable to care for them at that moment.

67. I then spoke with Nicole the ex- girlfriend of Malik and asked her what happened, Nicole said that
68. she exited Malik's vehicle and was heading towards her apartment when she noticed Raekwon approaching
69. her, yelling and causing a scene. Raekwon was upset that Nicole received a ride home despite not having
70. a car, and he went into the parking lot to identify the person who dropped her off. Nicole mentioned
71. that Raekwon spotted the vehicle Malik was in and started shouting and advancing toward the vehicle,
72. saying, "Nigga, let's go." It was at that moment that Malik began firing multiple shots as Raekwon
73. approached the vehicle. Nicole recalled that Malik said something before he shot, but she was unsure
74. of the exact words.

77. When Malik fired, Raekwon stood still for a brief moment before collapsing to the ground, bleeding.
78. Nicole applied pressure to his wounds and called 911. She stated that while Malik was shooting, she
79. was screaming for him to stop repeatedly. Nicole also noted that Malik had already parked the car before
80. the shooting occurred.

83. Raekwon was transported to HCA located at 1401 W Seminole Blvd, Sanford, Florida 32771. Officer
84. Agosto accompanied Raekwon, who is currently in the operating room for the multiple gunshot wounds
85. he sustained.

88. I also informed DCF and had a conversation with agent London, badge number #317, who indicated that
89. this incident qualifies for an investigation. DCF will initiate an investigation and start compiling
90. a report on their side.

93. I had Nicole provide a sworn written police statement, and a crime scene log was established shortly
94. after the shooting occurred. Additionally, I obtained a sworn written police statement from Nicole's
95. mother, Nancy Castellano, DOB: 10/21/1974, who was on the phone with her during the shooting, as completed
96. by detective Martell.

99. Malik was subsequently transported to the Volusia County Branch Jail without incident.
